

Between the months of December 2019 and April 2020, Okaloosa County Sheriff's Office received information that one of the co-defendants was distributing methamphetamine and heroin from the residence.

A check through the Okaloosa County Sheriff's Office Database revealed there were three reported drug overdoses at the residence; March 3, 2020, April 5, 2020, and May 11, 2020. The defendant, SHAWNNA SUE HARDIE, was present during all three incidents.

On May 21, 2020, Investigator K. Howard, along with members of the Okaloosa County Sheriff's Office Multi-Agency Drug Task Force, lawfully executed a narcotics search warrant at [REDACTED] Blackstone Road, Mary Esther, Florida. The search warrant was signed by the Honorable Judge Angela Mason on May 13, 2020.

During the search of the residence, where HARDIE resides, investigators located in her bedroom a used cotton swabs and a prescription bottle on HARDIE'S dresser. The prescription bottle contained approximately 1 gram of a clear liquid substance. Inside one of the dresser drawers, investigators located a make-up bag that contained a used syringe. At the foot of the bed, on the floor, and inside a medium size bag, investigators located two plastic baggies with a residual of a white powder. The above items were field-tested and tested positive for either methamphetamine and/or fentanyl. These items were found in the same bedroom where [REDACTED] four-year-old [REDACTED] was sleeping.

Post Miranda, HARRIS admitted [REDACTED] bedroom. She denied using narcotics and stated she was unaware of what was occurring in and around her residence.

Based on the above information, I have reason to believe and do believe the defendant, SHAWNNA SUE HARDIE violated provisions of F.S.S. 827.03(2)(d) child neglect without causing great bodily harm, F.S.S. 823.10(1) public nuisance to wit; a dwelling used for keeping, selling or delivering illegal narcotic, F.S.S. 893.13(6)(a) possession of a controlled substance to wit; methamphetamine F.S.S 893.147(1) possession of drug paraphernalia. This incident occurred in Okaloosa County, where I am a sworn law enforcement officer.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Between the months of March 2020 and May 2020 three separate incidents of an opiate related overdose occurred at 671 Blackstone Road, Mary Esther, Florida in which life saving measures were needed to save the lives of the individuals involved.

On May 21, 2020 members of the Okaloosa County Sheriff's Office Narcotics Unit executed a search warrant at [REDACTED] Blackstone Road, Mary Esther, Florida. The search warrant was signed by the Honorable Judge Angela Mason on May 13, 2020.

Contact was made with the Defendant, Nikolaus Wallace, who was in the covered carport area. Post Miranda the Defendant admitted to living at the residence by sleeping in the living room, paying rent at the residence, and using Methamphetamine and marijuana while at the residence. He was also a recovering heroin addict. The Defendant was observed within the residence during at least one of the overdose incidents.

During a search of the residence the following items were located:

- Miscellaneous drug paraphernalia to include small jeweler bags with residue, used foil, plastic containers with residue, and used syringes.
- A baggie located in the living room field tested presumptive positive for the presence of Heroin
- A baggie located in a co-defendant's bedroom field tested presumptive positive for the presence of Fentanyl
- A bottle located in a co-defendant's bedroom field tested presumptive positive for the presence of Heroin

The Defendant's criminal history revealed he has prior arrests for narcotic offenses to include Possession of Marijuana with intent to sell (2013), Possession of Cocaine (2013), Possession of a Controlled Substance (2016), Possession of Drug Paraphernalia (2016), Possession of Heroin (2017), and Possession of Drug Paraphernalia (2017). Furthermore, the Defendant served time in the Florida Department of Correction for Possession of Heroin and Possession of a Controlled Substance and was released on March 8, 2018.

Based upon my investigation and previous reports of narcotics activity occurring at this residence, there is probable cause to believe that this residence is a Public Nuisance where controlled substances are illegally kept, sold, or used.

Based on the aforementioned facts and investigation, Your Affiant has reason to believe and does believe the Defendant, Nikolaus Wallace, violated F.S.S. §23.10(1) Keeping a Public Nuisance Structure for Drug Activity and F.S.S. 893.147(1)-Possession of Drug Paraphernalia. This incident occurred in Okaloosa County, Florida where your Affiant is a full time sworn Law Enforcement Officer.

During the execution of the Search Warrant, Kurtlan MCNAMARA, was located just inside the front door of the residence and was the first person detained from the front of the residence. Immediately to the left of the front door is a white chair. On the arm of the chair, closest to the front door was a plastic baggie with less than 1 gram of suspected heroin. The suspected heroin field tested presumptive positive using an issued field test kit. Further, after MCNAMARA was detained, he asked for a cigarette. MCNAMARA advised his cigarette were on the white chair and pointed to them. These cigarette were within 4-5 inches from where the heroin was located.

MCNAMARA's hands were swabbed with a sterile swab. The swab was then field tested and tested presumptive positive for the presence of heroin using an issued field test kit.

During a post Miranda interview, MCNAMARA denied ownership of the heroin and stated he had not touched heroin in a while.

During a post Miranda interview, Shawna HARDIE stated MCNAMARA was sitting in the chair just prior to law enforcement knocking on the door.

Based on the above information your Affiant believes the defendant Kurtland MCNAMARA did willfully violate F.S.S. 893.13.6a possession of a controlled substance. This offense occurred within Okaloosa County, Florida.
