[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 3, 2020, Jonathan KENDRICK (Defendant/Driver) was arrested for Fleeing or Eluding a Law Enforcement Officer with Lights and Sirens Active, Resisting an Officer Without Violence, and Driving Without a Valid License.

On the above-listed date, Okaloosa County Sheriff's Office (OCSO) Dispatch received information of a stolen white 2008 Gulf RV, bearing Florida registration Y92QH, traveling north on Highway 85, Crestview, Okaloosa County, Florida.

Based on the above information, I traveled to the intersection of Highway 85 and Rattlesnake Bluff Road, Crestview, in attempts to intercept the RV. A short time later, I observed the RV traveling north on Highway 85 and prepared to turn west (Left) onto Rattlesnake Bluff Road. During this time, I observed a white male operating the RV and he was later identified as the Defendant.

As the RV turned onto Rattlesnake Bluff Road, I attempted to conduct a traffic stop on the RV by activating the emergency equipment on my marked Okaloosa County Sheriff's Office (OCSO) patrol vehicle. The RV continued traveling west on Rattlesnake Bluff Road at thirty-six (36) miles per hour. While continuing to travel along Rattlesnake Bluff Road, the RV nearly struck another vehicle as it passed the vehicle using the opposite lane of travel.

After traveling nearly 0.5 miles, the RV turned north (Right) onto a dirt trail. While the RV continued traveling on the trail, the RV side swiped a tree, causing the side awning to break off. As the RV continued through the trail, the RV completed between ten (10) and twelve (12) turns over a distance of approximately .08 miles. A short time later the RV struck a tree, disabling the RV from traveling any further. I then observed the Defendant exit the RV from the driver seat and take flight on foot north through the trail and I gave chase.

During the foot pursuit, I gave multiple loud verbal commands for the Defendant to stop, and the Defendant refused to comply. After approximately 0.045 miles, the Defendant stopped and eventually got onto the ground, where he was placed into hand restraints.

Post Miranda, the Defendant stated he knew the RV was stolen but denied being the person(s) who stole it. The Defendant stated he did not view my lights or hear my siren until he turned onto the dirt trail. The Defendant stated he continued on the trail in attempts to elude me, as he was aware he had an active warrant out of Escambia County, Florida. The Defendant also stated he has never possessed a valid driver's license.

Based on the above, I have probable cause to believe the Defendant, Jonathan KENDRICK, violated Florida State Statutes 316.1935.2 Flee or Elude a Law Enforcement Officer with Lights and Sirens Active; 843.02: Resist Officer Without Violence; and 322.03.1 Operating a Motor Vehicle Without Valid Driver's License. This incident took place within Okaloosa County, Florida.
