[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Chad Biernacki, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since November 2019. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant previously served as a Deputy Sheriff for 12 years with the Walton County Sheriff's Office. Your Affiant being duly sworn states as follows:

On June 16, 2020, at 0420 hours John Paul TERRY (Defendant) was at his residence located at  Rickey Street Unit 7, Fort Walton Beach, Okaloosa County, Florida. The Defendant was drinking alcoholic beverages when he

armed himself with a .45 caliber Glock [redacted] and a .357 Glock serial number [redacted]

Once armed the Defendant contacted [redacted] (Witness) who had been sleeping in the upstairs bedroom. The Defendant advised the Witness he had seen aliens and requested to be let in the room. The Witness in turn locked the bedroom door. The Defendant then fired four rounds from the Glock .45 into the bedroom. One of the rounds penetrated the bedroom door and exited the residence through the bedroom window and crossing over the public right of way for Rickey Avenue. The other three rounds also penetrated the door with one of them damaging the lock. Those rounds all lodged in the dry wall of the bedroom. Due to the damaged lock the Defendant gained access to the room. The Witness fled the room and the residence in fear of being shot.

At 0430 hours the Defendant contacted the Okaloosa County Dispatch and requested a Deputy respond to his residence to investigate thirty (30) or more round being fired from a rifle in the immediate area of the residence approximately thirty (30) minutes prior to his call.

At 0437 hours, your Affiant arrived on scene and could hear the Defendant talking through the closed front door. Your Affiant knocked on the door and heard the Defendant telling someone he was going to shoot whoever was at his door.

Your Affiant retreated from the doorway as he requested Dispatch advise the Defendant it was Deputies knocking on his door. Your Affiant took a position of cover and shortly after doing so your Affiant heard the first shot come from within the residence. From approximately 0440 hours to 0513 hours a suspected seven (7) to nine (9) shots were fired by the Defendant from both the .45 caliber Glock and the .357 caliber Glock. One of the rounds fired did exit the Defendants residence through the drywall and enter the adjoining neighbor's garage at [redacted]

At 0513 hours, the Defendant exited the residence and surrendered without incident to your Affiant. A search incident arrest of the Defendant's person revealed the following:

-One (1) .45 caliber Glock serial number [redacted] loaded with one round chambered, found in the Defendants front right pocket.

-Three loaded (3) .45 caliber Glock magazines found in the Defendant's front pockets.

Post Miranda the Defendant requested an Attorney prior to any questioning.

Based on the above, your Affiant has probable cause to believe the Defendant, John TERRY, violated Florida State Statutes: 790.151 Using/Discharging a Firearm while Intoxicated, 790.15.1; Discharging a Firearm over a Public Roadway, and 790.19 Firing a Deadly Missile into a Dwelling.
