[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 25, 2020, the Okaloosa County Sheriff's Office Street Crimes Unit was conducting proactive patrols in the area of Niceville, Florida.

During these patrols, your Affiant observed a red in color Ford Mustang later observed to have been displaying expired Georgia temporary tag: S0324744, roll the stop sign at the corner of County Line Road, and Highway 20. The Defendant/Driver was later identified as Kevin Wade McLaren, who was traveling with the witness/passenger.

A traffic stop was attempted in the area of Highway 20 and the Highway 293 Overpass, where the vehicle fled Westbound to Cat-mar Road, then North on Cat-Mar Road, where the vehicle came to a stop at the corner of Cat-Mar Road and Cypress Street. During the pursuit, your Affiant was following the Defendant with his agency issued patrol vehicle with its emergency lights and siren activated. As the vehicle came to a stop, the driver was given commands to "stop reaching." The Defendant had to be removed from the vehicle, at which time he pulled away and was escorted to the ground.

During your Affiant's investigation, D/S T. Costantini arrived on scene with his trained narcotics detection K9 "Rocco" and conducted a free air sniff of the vehicle. I was advised by D/S T. Costantini that "Rocco" provided a positive alert to the odor of illegal narcotics emanating from the vehicle.

During a probable cause search of the vehicle, the following was located within the vehicle's glove compartment: approximately one gram of suspected Methamphetamine, approximately less than one gram of suspected Fentanyl, one and a half Suboxone tablets with the markings "54 411" (identified using Drugs.com), and a suspected Methamphetamine Pipe. Each item/substance was field tested and produced a presumptive positive response for the presence of their perspective substance. During the search of the Defendant's wallet, two identification cards were located, which did not belong to the Defendant.

The Defendant was queried by dispatch through FCIC/NCIC, where it was learned his license was suspended and has been suspended multiple times in the past. A query of the Defendant through the Driver and Vehicle Information Database (DAVID) where it was learned he has had two previous suspensions which were adjudicated as GUILTY on 04/17/2014 and 12/10/2019. It was also learned the Defendant was currently on Felony Probation. Your Affiant contacted

the Emergency Action Center and spoke with Duty Officer Mccray, who advised the Defendant is currently on probation until March 4, 2022, for the original offense of Possession of Marijuana and Uttering Forged Bills.

Post Miranda, the Defendant stated he bought the vehicle approximately three weeks prior and had failed to register or insure the vehicle. The Defendant advised he was not sure if his license was valid or not. When asked if there were narcotics inside the vehicle, the Defendant stated there shouldn't be. The Defendant stated he does use "ice" of Methamphetamine and used a few days prior.

The passenger/witness provided a sworn statement advising the following: He and the Defendant went to pick up some car parts. As they were headed home, he noticed they were getting pulled over, but the Defendant was not pulling over. He stated the Defendant was asking him to switch seats with him as he was continuing to roll. The witness told the Defendant multiple times to pull over, but when he finally did, he grabbed an unknown item from the driver's side of the car, opened the glove compartment, and shoved it inside.

Based on your Affiant's investigation, the Defendant, Kevin Wade McLaren, violated the following: FSS 316.1935 Fleeing and Eluding, FSS 322.34(2)(c) DWLSR 3rd or Subsequent Offense, FSS 324.221(2) Financial Responsibility (Insurance), FSS 320.02(1) Fail to Register a Motor Vehicle, FSS 817.5685(1) Unlawful Possession of Someone Else's Identification Card, FSS 893.13(6)(a) Possession of a Controlled Substance (3 counts) (Methamphetamine/Fentynal/Suboxone), FSS 893.147 Possession of Paraphernalia, and FSS 948.06 Violation of Felony Probation. These offenses are contrary to law as such case provided and against the peace and dignity of the State of Florida.
