[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 12, 2020, at approximately 0130 hours, the Defendant, Kereng Ikerdeu Naburn, violated FSS 784.045 (1a2) Aggravated Battery with a Deadly Weapon (DOMV) by stabbing her husband/victim, Franklin Ronquillo Naburn, multiple times on his person.

Victim, Franklin Naburn, in a sworn verbal statement, stated he and the Defendant were engaged in a verbal altercation while inside their residence located at [REDACTED] Florida. During the altercation he elected to leave the residence and go for a walk around the neighborhood. While walking on Woodland Park Circle, three unknown males "jumped" him and stabbed him from behind. A canvass was conducted on Woodland Park Circle and there was no evidence to substantiate the victim's statement. The victim denied the Defendant caused the injuries he sustained from being stabbed.

It should be noted the Victim made the spontaneous statement "You guys can come back and get her later" when she was placed in handcuffs.

The victim was transported to the Fort Walton Beach Medical Center for multiple lacerations, consistent with stab wounds, on his head, face, arm and back. Per medical staff, the victim sustained a punctured left lung which caused his left lung to collapse.

The Defendant, Kereng Ikerdeu Naburn, refused to speak to me post Miranda advisement.

The Defendant's clothing was covered in suspected blood however she denied having any injuries.

[REDACTED] was observed to have a small cut

on the upper portion of his left arm. A specialized interview was attempted with the child but did not result in additional information.

Witness, [redacted] Woodland Park Circle, Mary Esther, Florida and advised he heard arguing coming from the Defendant's and Victim's residence just prior to law enforcement's arrival.

The Defendant and Victim are married, have a child in common and currently reside with one another as a family.

A search warrant was executed on their residence, located at [redacted] Mary Esther, Florida which resulted in locating a kitchen knife described as having a silver smooth blade with suspected blood on the blade. The knife was located on the floor of [redacted] bedroom. Suspected blood was located throughout the residence.

Based on the above stated facts I have reason to believe and do believe the Defendant, Kereng Ikerdeu Naburn, violated Florida State Statute 784.045 (1a2) Aggravated Battery with a Deadly Weapon (DOMV). This offense occurred in Okaloosa County where I am a sworn law enforcement officer.


