[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 7/13/2020 on N. Ferdon Bd., just south of the intersection at Stillwell Bd., Crestview and at 802 N. Ferdon Bd. (Tom Thumb) Crestview, FL, the defendant, Jake Bell, committed Child Abuse, Battery, Criminal Mischief and Resisting without Violence to wit:

At the Tom Thumb, the defendant did strike victim, Rebecca Rooney, in her face just below her left eye, with a closed fist. This caused some light redness on her cheek on and just under the cheek bone area. She was struck so hard her glasses were knocked off and became damaged when they hit the ground. This was witnessed by victim Eugene Guillory, Travis York, Stephanie York and [REDACTED] who all provided sworn statements.

The defendant then struck victim, Eugene Guillory, in his right shoulder with a closed fist. This was also witnessed by victim Rebecca Rooney, Travis York and Stephanie York.

The defendant then ran from the store and headed south on N. Ferdon Bd., from the Stillwell Bd., intersection. He then came up to victim, [REDACTED] and attempted to kick through the rear driver side passenger window, but missed and struck the door just above the handle. This caused a dent in the door. Victim (3 YOA), sat in the seat by the door struck by the defendant. The driver/witness and father, [REDACTED] managed to pull the vehicle ahead just as the defendant kicked. The victim would have been struck in the head had the vehicle not been able to be moved. The victim also said she was in fear. [REDACTED] estimated the damage around \$800 pending a quote from his insurance. This was witnessed by the middle passenger (10 YOA), Megan Steele and victim Eugene Guillory.

The defendant also refused commands to stop by Inv. Dustin Rice, who attempted to detain him. The defendant pulled away when Inv. Rice attempted to grab his arm in order to place the defendant in handcuffs. The defendant had to be placed in an arm bar for control and a Crestview Police Officer had to be used to gain the control of the other arm to allow handcuffs to finally be secured. This was witnessed by Jordan and Megan Steele.

The defendant, Jake Bell, committed the offenses of Child Abuse pursuant to F.S.S. 827.03.2c, two counts of Battery pursuant to F.S.S. 784.03.1a1, Criminal Mischief pursuant to F.S.S. 806.13.1b2 and Resisting without Violence pursuant to F.S.S. 843.02. These offenses occurred in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.
