The Defendant failed to exit the residence and entry was made. Upon reaching where the Defendant was located the door had to be breached in an effort to gain access. The Defendant was then taken into custody.

Your Affiant is currently assigned to the OC SO Special Investigations Section Drug Task Force. Your Affiant was previously employed by the Crestview Police Department for approximately 10 years. Your Affiant being duly sworn states as follows:

On 07/20/2020, your Affiant along with members of the OC SO Drug Task Force executed a lawful search warrant at 110 Bob Sikes Boulevard, Fort Walton Beach Florida. In execution of the warrant your Affiant, learned the Defendant, Elizabeth Ashley Burnett was living in the back bedroom along with his Co-Defendant, Charles Alexander Dozier. During a search of the Defendants living quarters a glass smoking device was located. Located in the glass smoking device was a reddish liquid, and methamphetamine residue. The liquid was field tested and yielded a presumptive positive result. The methamphetamine liquid was later weighed at 63 grams. [STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Investigator Pierre Batiste, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since January 2017. Your Affiant is currently assigned to the OCSO Special Investigations Section Drug Task Force. Your Affiant was previously employed by the Crestview Police Department for approximately 10 years. Your Affiant being duly sworn states as follows:

On 07/20/2020, your Affiant along with members of the OCSO Drug Task Force executed a lawful search warrant at 110 Bob Sikes Boulevard, Fort Walton Beach Florida. In execution of the warrant, your Affiant, learned the Defendant Charles Alexander Dozier was living in the back bedroom along with his Co-Defendant, Elizabeth Burnett. During a search of the Defendant's living quarters a glass smoking device was located. Located in the glass smoking device was a reddish liquid, and methamphetamine residue. The liquid was field tested and yielded a presumptive positive result. The methamphetamine liquid was later weighed at 63 grams. There were several other glass smoking devices which contained suspected methamphetamine residue located.

During the initial execution of the warrant, several announcements were made for the Defendant and other occupants to exit the residence. The Defendant failed to exit the residence and entry was made. Upon reaching the Defendant's living quarters the door had to be breached in an effort to gain access. The Defendant was then taken into custody.

Post Miranda your Affiant learned via testimony, the Defendant state he had paraphernalia contained within his living quarters along with a little bit of marijuana.

The Defendant was transported to the Sheriff's Office Booking Facility. During a search of the Defendant's person a small baggie of suspected methamphetamine was located in his pants pocket. The methamphetamine was field tested and yielded and presumptive positive result. The methamphetamine was later weighed at 1 gram.

In reviewing the prior calls for service at this residence, your Affiant learned opioid overdoses were reported at this address on May 14, 2020, June 13, 2020, and June 17, 2020. In each of the prior overdose responses, paraphernalia and suspected heroin was recovered. Each of the subjects in the prior calls for overdose were not residents at that address. Your Affiant learned in the course of this investigation, this particular residence had been previously reported to be a known narcotics location and was under periodic surveillance at the time this incident occurred.

Based on the above, your Affiant has probable cause to believe the Defendant violated Florida State Statute's Trafficking in Methamphetamine 893.135 (1)(f)(1), Possession of Controlled Substance 893.13 (6)(a), Possession of Drug Paraphernalia 893.147, Resisting an Officer without violence 843.02, Keeping a residence which is visited by persons for the purpose of unlawfully using any substance controlled under chapter 893 or any drugs as described in chapter 499, 823.10 (1), and Introduction of contraband into a Detention Facility 951.22.
