[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On July 27, 2020, members of the Okaloosa County Sheriff's Office Multi-Agency Drug Task Force executed a search warrant at 5 Moroni Court, Fort Walton Beach, Florida.

Contact was made with the defendant, David Abbott, who had to be removed from a shed, that was converted to a living quarters, located on the premises. Multiple lawful commands, such as "Sheriff's Office, Search Warrant" were given to the occupants of the shed for approximately two minutes. The Defendant and a Co Defendant refused to unlatch the door and exit the shed. Investigators had to pry open the door and remove the Defendant and Co-Defendant from the shed.

During a search of the shed, identified as the Co-Defendant's bedroom, the following items were located:
-Approximately 1 gram of a crystal like substance, which field tested a presumptive positive for Methamphetamine
-Approximately 1 gram of tan, powdery substance, which field tested a presumptive positive for Heroin
-Multiple items of drug paraphernalia to include digital scales, glass smoking devices with methamphetamine residue, loaded and used syringes, multiple small clear jewelers bags, and a spoon with residue

Post Miranda the Defendant denied knowledge or ownership of the illegal items in the shed.

The Defendant was in possession of a cell phone when he was removed from the shed. A review of the cell phone revealed messages requesting "Clear" slang for methamphetamine. The Defendant stated he had "bout 2 g" slang for 2 grams, on him.

The Co-Defendant stated the Defendant came to the residence with her to "smoke" and he brought his own.

Based upon the aforementioned facts and investigation, your Affiant has reason to believe and does believe the Defendant, David Abbott, violated F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Methamphetamine, F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Heroin, and F.S.S. 843.02-Resisting an officer without violence. This incident occurred in Okaloosa County, Florida where your Affiant is a full time sworn Law Enforcement Officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

- Approximately 1 gram of a crystal like substance, which field tested a presumptive positive for Methamphetamine
- Approximately 1 gram of tan, powdery substance, which field tested a presumptive positive for Heroin
- Multiple items of drug paraphernalia to include digital scales, glass smoking devices with methamphetamine residue, loaded and used syringes, multiple small clear jewelers bags, and a spoon with residue
- A box, approximately half full, of .25 caliber Remington ammunition

The Defendant's criminal history showed she was a convicted felon dating back to 2011 and was convicted of possession of ammunition or a firearm by a convicted felon in 2018 in Santa Rosa County, Florida.

Post Miranda the Defendant denied knowledge or ownership of the illegal items in the shed, however, she stated some of the clothing and boxes were hers.

Based upon the aforementioned facts and investigation, your Affiant has reason to believe and does believe the Defendant, Jessica Foster, violated F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Methamphetamine, F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Heroin, F.S.S. 790.23(1)-Possession of ammunition by a convicted felon, and F.S.S. 843.02-Resisting an officer without violence. This incident occurred in Okaloosa County, Florida where your Affiant is a full time sworn Law Enforcement Officer.
