On July 27, 2020, members of the Okaloosa County Sheriff's Office Multi-Agency Drug Task Force executed a search warrant at 5 Moroni Court, Fort Walton Beach, Florida.

Contact was made with the defendant, Jessica Foster, who had to be removed from a shed, that was converted to a living quarters, located on the premises. Multiple lawful commands, such as "Sheriff's Office, Search Warrant" were given to the occupants of the shed for approximately two minutes. The Defendant and a Co-Defendant refused to unlatch the door and exit the shed. Investigators had to pry open the door and remove the Defendant and Co-Defendant from the shed.

During a search of the shed, identified as the Defendant's bedroom, by her belongings and her name on the

walls, the following items were located:
-Approximately 1 gram of a crystal like substance, which field tested a presumptive positive for
Methamphetamine
-Approximately 1 gram of tan, powdery substance, which field tested a presumptive positive for Heroin
-Multiple items of drug paraphernalia to include digital scales, glass smoking devices with methamphetamine

The Defendant's criminal history showed she was a convicted felon dating back to 2011 and was convicted of possession of ammunition or a firearm by a convicted felon in 2018 in Santa Rosa County, Florida.

Post Miranda the Defendant denied knowledge or ownership of the illegal items in the shed, however, she stated some of the clothing and boxes were hers.
