[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 29, 2020, the defendant, Tremell Azarey Gilbert, did in fact violate F.S.S. 810.02(2b)- Armed Vehicle Burglary and F.S.S. 812.014(2c5)- Grand Theft of Firearm. These offenses occurred at the Islander Condominium, 502 Gulf Shore Drive, Destin, Florida.

On July 29, 2020, the defendant, along with co-defendants Anderson, Tupman, Christensen and Taylor, conspired amongst each other to commit vehicle burglaries at the Islander Condominium in Destin, FL. The defendant and co-defendants were located after a vehicle pursuit with law enforcement officers and detained.

The defendant refused to cooperate with the investigation. However, interviews with co-defendants Anderson, Tupman, and Christensen, detailed the defendant's plan to enter vehicles to locate firearms. The defendant was said to have given instruction to turn over all stolen firearms to him. Co-defendant Christensen advised that she obtained a firearm from a Jeep Wrangler and provided it to the defendant.

The co-defendants, Anderson, Tupman, Christensen, and Taylor, advised that the defendant operated the vehicle at times during the night.

During the burglaries, co-defendant Christensen located, and took into her possession, a .38 special revolver firearm from a 2013 white Jeep Wrangler. The actions were conducted with the knowledge and intent to deprive the victim of his property. The burglary was captured of surveillance video.

Due to the defendant having knowledge of and being engaged in the criminal activity, he will be charged as a principal.

An Affidavit of Complaint was completed by the victim.

Based on my investigation, I have reason to believe that the defendant, Tremell Azarey Gilbert, did in fact violate the above mentioned statutes. These offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.

On July 29, 2020, your Affiant responded to 502 Gulf Shore Drive, Destin, Florida in reference to a report of juvenile who advised the reporting person that she was with an older male in a blue SUV. The reporting person stated the juvenile female was scared to be with the male and wanted a ride home.

Your Affiant arrived on scene and began to park just inside the entrance to the condominium. Upon sight of your Affiant's marked patrol vehicle, subjects began running across the parking lot and entered a blue Chevrolet Tahoe with Florida tag Y66JWZ. Based on the above information, your Affiant had reason to believe criminal activity was occurring. Your Affiant ran toward the Tahoe and yelled for the vehicle to stop as it sped away. [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 29, 2020, the suspect, Keelee Christensen, did in fact violate F.S.S. 810.02(2b)- Armed Vehicle Burglary and F.S.S. 812.014(2c5)- Grand Theft of Firearm. These offenses occurred at the Islander Condominium, 502 Gulf Shore Drive, Destin, Florida.

On July 29, 2020, the defendant, along with three additional co-defendants, conspired amongst each other to commit vehicle burglaries at the Islander Condominium in Destin, FL. The defendant and co-defendants were located after a vehicle pursuit with law enforcement officers and detained.

The defendant was read Miranda rights via prepared text. Post-Miranda, the defendant admitted to engaging in vehicle burglaries with the intent of stealing currency and firearms. She, specifically, stated that she attempted to enter several vehicles and was successful in stealing a firearm. The defendant advised that co-defendant Gilbert instructed her on how to enter vehicle and to turn any firearms over to him, which she did.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 29, 2020, the suspect, Jalen Rashon Taylor, did in fact violate F.S.S. 810.02(2b)- Armed Vehicle Burglary and F.S.S. 812.014(2c5)- Grand Theft of Firearm. These offenses occurred at the Islander Condominium, 502 Gulf Shore Drive, Destin, Florida.

On July 29, 2020, the defendant, along with three additional co-defendants, conspired amongst each other to commit vehicle burglaries at the Islander Condominium in Destin, FL. The defendant and co-defendants were located after a vehicle pursuit with law enforcement officers and detained.

The defendant was read Miranda rights via prepared text. Post-Miranda, the defendant admitted to engaging in vehicle burglaries with the intent of stealing currency and firearms. He, specifically, stated that he attempted to enter several vehicles but was unsuccessful. He admitted to driving the vehicle during parts of the night.

The defendant acknowledged that he was aware of the other co-defendants also engaging the vehicle burglaries. The defendant identified the other co-defendants, Christensen and Gilbert, involved in the activity. The defendant only knew the co-conspirator, that fled, as Charles but advised he was involved in the burglaries as well.
