On August 3, 2019, at approximately 2030 hours, the Defendant, Alesi Castillo, violated FSS 794.011.3 Sexual Assault with force by threatening physical harm and FSS 794.011.3 Aggravated Battery.							
The Victim, stated in a sworn statement she was at the "Hang Challenge" kiosk at 10 Harbor							
Blvd, Destin, where she met the Defendant, Alesi Castillo, an employee of that kiosk who identified himself as "Michael." The Defendant provided the Victim with some green "slushy" drinks which she did not realize contained alcohol until she felt intoxicated. The Victim then left with the Defendant thinking he was walking her back to her hotel room. However, the Defendant led her across the street to a park at 131 Calhoun Drive, Destin, where he pushed her against a tree and claimed she said she wanted to have sex with him. When the Victim said no, the Defendant squeezed her by the throat							
until she was unable to breathe and began to lose her vision. The Defendant proceeded to get behind her and put her in a headlock. He digitally penetrated her anus which caused the victim to defecate. During this time she was able to scratch							

During a photo array, the Victim identified the Defendant, Alesi Castillo, aka: "Michael," as the person who

and bite the Defendant on the arm. She then fled the scene and screamed for help.

attacked and penetrated her. Additionally, investigating deputies observed the Defendant with scratches on his arm and possible fecal matter on his shorts and one of his shoes.

Post Miranda, the Defendant admitted to meeting the Victim at the "Hang Challenge" where she was intoxicated and flirting with customers and other employees. At his bosses' direction, the Defendant escorted the victim away from the business whereupon they were met by a black male who claimed to be the victim's boyfriend. The Defendant claimed he turned the victim over to her boyfriend and returned to his place of employment. The Defendant was unable to definitively explain how he got "poop" on his shoe and shorts, and assumed it came from the Victim when she "stumbled into him."

A sexual assault kit was completed and subsequent FDLE analysis of the victim's biological swabs and clothing failed to identify sufficient DNA to establish a male profile. Your Affiant observed the victim had a bloody nose and bruising on her forehead which she advised had occurred during the assault.

Based on the above-stated facts, your Affiant has reason to believe the Defendant, Alesi Castillo, violated Florida State Statutes 794.011.3, Sexual Assault with force; and 794.011.3, Aggravated Battery. These offenses occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
