[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 29, 2020, the suspect, Rozelle Tyrone Lee Payton, did in fact violate F.S.S. 810.02(2b)- Armed Vehicle Burglary, F.S.S. 812.014(2c5)- Grand Theft of Firearm, and F.S.S 843.02- Resting without violence. These offenses occurred at the Islander Condominium, 502 Gulf Shore Drive, Destin, Florida.

On July 29, 2020, the defendant, along with three additional co-defendants, conspired amongst each other to commit vehicle burglaries at the Islander Condominium in Destin, FL. The co-defendants were located after a vehicle pursuit with law enforcement officers and the defendant fled without being apprehended.

Interviews with co-defendants Christensen and Taylor detailed the defendant's plan to enter vehicles to locate firearms. The defendant was specifically described as being a part of the burglaries and a description was provided. They explained that upon sight of law enforcement, Payton fled the scene.

During the burglaries, co-defendant Christensen located, and took into her possession, a .38 special revolver firearm from a 2013 white Jeep Wrangler. The actions were conducted with the knowledge and intent to deprive the victim of his property. The burglary was capture of surveillance video.

During the course of the investigation, the defendant was obtained by querying the nickname provided by the co-defendants, Taylor and Christensen. Querying the nickname led law enforcement to the defendant. A photo line-up was provided to co-defendant Christensen and a witness Tupman, who ultimately identified the defendant as the one who fled the scene.

Due to the defendant having knowledge of the criminal activity and taking part in the activity, he will be charged as a principal.

An Affidavit of Complaint was completed by the victim.

Based on my investigation, I have reason to believe that the defendant, Rozelle Tyrone Lee Payton , did in fact violate the above mentioned statutes. These offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.

The firearm was completely concealed, unholstered, and readily accessible. The Defendant does not possess a Conceal Carry Weapon (CCW.)
