[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 12, 2020, members of the Okaloosa County Sheriff's Office Multi-Agency Drug Task Force executed a search warrant at 398 North Spring Street, Crestview, Florida.

Contact was made with the defendant, William Beatty, who was the sole occupant of the residence, after he exited the front door of the residence.

During a search of the residence, identified as the Defendant's, by the Okaloosa County Property Appraisers website, as well as his own admissions, the following items were located:

- -Less than 1 gram of a tan, powdery substance on the lid to a digital scale, which field tested a presumptive positive for Fentanyl
- -5 white pills stamped, "G037" which are identified as acetaminophen/hydrocodone (Lortab), according to Drugs.com, which is a Schedule II controlled substance. These were located next to the Defendant's bed.
- -Multiple items of drug paraphernalia to include digital scales, glass smoking devices with suspected methamphetamine residue, loaded and used syringes, multiple small clear bags with the corners missing, and a spoon with residue
 - -A box containing 12 rounds of Hornady .38 Special ammunition from a safe in the Defendant's bedroom
- -A prescription bottle weighing approximately 61 grams with a dark liquid, later confirmed to be the Defendant's blood by his admission, tested a presumptive positive for Heroin. The Defendant stated post Miranda that he would withdrawal his blood while "high" so he could re-inject it later to get "high" to avoid getting sick.

The Defendant's criminal history showed he was a convicted felon dating back to 1995 and has prior convictions for Robbery, Possession of Controlled Substances, Destruction of Evidence, and a recent arrest in March of 2020 for Trafficking in Heroin by the Crestview Police Department. The Defendant is currently out on bond.

Post Miranda, the Defendant stated he was just a "user" of Heroin, and denied selling any controlled substances. When questioned about the Lortabs located in his bedroom the Defendant stated they were antibiotics but later stated the Lortabs help with his headaches. The Defendant stated he was in possession of a firearm, specifically a revolver, last year but likely traded it for Heroin, but forgot about possessing the ammunition. The Defendant confirmed he was a convicted felon.

A review of a cell phone, the Defendant stated was his, revealed multiple text messages to individuals stating he was "good" meaning he had narcotics for sale and even inquired if anyone needed any and requested they also sell narcotics for him.

Based upon my investigation and previous reports of narcotics activity occurring at this residence, there is probable cause to believe that this residence is a Public Nuisance where controlled substances are illegally kept, sold, or used.

Based upon the aforementioned facts and investigation, your Affiant has reason to believe and does believe the Defendant, William Beatty, violated F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Heroin, F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Hyrdrocodone, F.S.S. 893.13(6a)-Possession of a controlled substance without a prescription-to wit Fentanyl, F.S.S. 893.147(1)-Possession of Drug Paraphernalia, F.S.S. 790.23(1)-Possession of ammunition by a convicted felon, F.S.S. 823.10(1)-Keeping a Public Nuisance Structure for Drug Activity. This incident occurred in Okaloosa County, Florida where your Affiant is a full time sworn Law Enforcement Officer.
